#### Courses offered:

- **5 Year Integrated Degree course - B.B.A. LL.B.(Hons.) & B.A. LL.B. (Hons.)**

Eligibility - 10+2 Examination or Equivalent  
45% for General & OBC & 40% for SC/ST  
Age - 20 years for General & 22 years for SC/ST/OBC

- **3 Year Degree course - LL.B. (Hons.)**

Eligibility - Graduation in any Discipline  
45% for General & OBC & 40% for SC/ST

- **2 Year PG Degree course - LL.M.**

Eligibility - Graduation in LL.B.  
55% for General & OBC & 50% for SC/ST
